Notice Requirement: Notice of the hearing on the maximum property tax dollars and of the proposed budget must be given not more than 20 days nor less than 10 days before the date of the hearing. New in 2024 and also needed for 2025, the maximum property tax hearing must not be before March 25th.

Detailed budget: The detailed budget must be available for public inspection at least 10 days before the final budget hearing and 20 days before final date for certification and is to be available at the clerk's and mayor's offices and the public library, or posted at three placed designated by ordinance if there is no library.
